BY-LAWS Chester Lodge No. 0094 A.F.A.M. Chester, Virginia

ARTICLE I

The stated communication of this lodge shall be held at the Masonic Temple 4111 Dodomeade Street, Chester, Virginia on the second Thursday of each month at 7:30 PM o'clock.

ARTICLE II

Every member of this Lodge except Treasurer, Secretary and Chaplain shall be charged by the Secretary with the sum of \$67.00 plus Grand Lodge dues and assessments as annual dues.

ARTICLE III

The total fees for the degrees in this Lodge, including that amount which must accompany the petition shall be <u>\$170.00</u> Dollars, payable as follows:

Forty \$40.00 Dollars for the degree of Entered Apprentice; and Forty \$40.00 Dollars for the degree of Fellowcraft; and Forty \$40.00 Dollars for the degree of Master Mason; and Fifty \$50.00 Dollars shall accompany the petition.

ARTICLE IV

The Treasurer shall receive an annual compensation of One hundred eighty (\$180.00) Dollars payable in twelve monthly installments.

ARTICLE V

The Secretary shall receive an annual compensation of Three hundred (\$300.00) Dollars payable in twelve monthly installments.

ARTICLE VI

The Tiler, or Acting Tiler, shall receive a compensation of Five (\$5.00) Dollars for each communication he attends in that capacity.

ARTICLE VII

The three Trustees, who shall be recommended by the Lodge and appointed by the Court having jurisdiction, shall at each annual stated communication in December make a report of the investment of all funds and condition of property entrusted to their care.

ARTICLE VIII

Any amendment proposed to these by-laws must be submitted in writing at a stated communication, lie over the required four weeks, the membership notified, and shall require a two thirds affirmative vote of the members present for its adoption.

CERTIFICATION

I certify that the by-laws, or amendments thereto, were submitted in writing and audibly read at the stated communication of this Lodge held on May 08, 2008, that is was ordered to lie over for the required four weeks; the membership being duly notified that action thereon was to be taken at the stated communication to be held on July 10, 2008 and that the said by-laws or amendments thereto were adopted by the required majority of members present.
